1 SUSTAINING MEMBERS	<ul style="list-style-type: none"> Sustaining members shall consist of corporates or organisations offering the assurance of providing sustained support to the Association in pursuit of its goals, where the subject of energy is the main business, and which contribute an annual subscription that is intended to ensure that the work of the Association is sustained. Sustaining members shall be entitled to a seat on the Board of the Association with full voting rights and shall be entitled to a seat on the SANEA Advisory Forum. Sustaining Members shall be entitled to appoint representatives and are entitled to the number of votes, exercised one each by their appointed representatives. Members in this category are entitled to a negotiated range of benefits in relation to their annual subscription. Included in the menu of options are: complimentary attendance at events, preferential branding, podium seating, preferential networking, secondment opportunities, in-house lectures and other appropriate benefits. 	50

3 ASSOCIATE MEMBERS	Associate members shall consist of established associations, institutes/institutions, non-governmental organisations, energy research or academic organisations with an interest in the South African energy industry that have relevant expertise to support the Association in pursuit of its goals. Associate members shall be entitled to appoint representatives and are entitled to the number of votes, exercised one each by their appointed representatives.	2
4 AFFILIATE / INDIVIDUAL MEMBERS	Affiliate / Individual members shall consist of individuals that exhibit an interest in and/or contribute their knowledge/expertise to support the attainment of the goals of the Association. Members in this category are entitled to one (1) vote. The following discounts are also available, if requested, for qualifying Affiliate / Individual Members:	
4a Full Member	Full members are considered to be established and do not receive any discount.	1
4b Youth Members	Youth members shall consist of individuals aged 35 years or younger and who can provide an identity document as proof of their age/date of birth.	1
4c Registered Students	Registered Student members shall consist of individuals aged 35 years or younger and who are a registered full-time student at a recognized academic institution and who can provide proof of student registration for 2018.	1
4d Retired Members	Retired members shall consist of individuals who are at least 65 years of age and who have been members [or nominated representatives of a member] of SANEA in another category for at least 5 years prior to being admitted as a 'Retired Member'.	1
